Hello from the AGIS PTA. We hope that you and your family had a wonderful summer. It is hard to believe that another school year is upon us. Our children are already hard at work with their studies and after school activities.

The PTA is comprised of parents/educators and is the largest volunteer child advocacy association in the nation. It's a registered nonprofit organization that helps our children become more successful students and provides relevant resources for families and communities. Fundraising plays an important role and enables the PTA to pay for countless student activities, various supplies and school equipment each year. Did you know that our AGIS PTA spends over \$250,000 annually? A significant portion of our budget is spent on student activities and programs that supplement initiatives lead by our school district. For example, technology support from our PTA this year alone includes \$12,000 for the classroom projector project, \$5,400 for First in Math licenses for grades 4/5 and \$2,200 for Accelerated Reader licenses for grades 3/4.

Customarily, AGIS PTA holds fall and spring catalog fundraisers. Last year these two events raised nearly \$29,000. Although these events are necessary in generating financial resources that directly benefit each of our children, they are very labor intensive. Given the fact that life keeps us all very busy, the AGIS PTA has decided to conduct a direct donation fundraiser instead of a catalog sale this fall. The money we raise will continue the great programs and initiatives we've had in the past such as: assemblies, academic competitions, technology support as mentioned above, student incentives, artist-in-residence and much more!
